**Skin contact:** Take off immediately all contaminated clothing. Get medical attention if irritation develops and persists. Wash skin thoroughly with soap and water for several minutes.

Section 5. Firefighting Measures

**Suitable extinguishing media:** Water spray, fog, CO<sub>2</sub>, dry chemical, or alcohol resistant foam. **Unsuitable extinguishing media:** Do not use a solid water stream as it may scatter and spread fire

**Methods and materials for containment and cleaning up:** Eliminate all ignition sources (no smoking, flares, sparks or flames in immediate area). Sweep up and place in a clearly labeled container for chemical waste. Wash contaminated area with water. Use only non-sparking tools. Avoid the generation of dusts during clean-up.
